

**WARNING****SPECIAL MEETING****WEST RIVER MODIFIED UNION EDUCATION DISTRICT**

November 6, 2018

The legal voters of the West River Modified Union Education District (the "District") comprising the voters of the Towns of Brookline, Jamaica, Newfane, and Townshend (all preK-grade 12) and the Town of Windham (for Grades 7-12), are hereby notified and warned to meet at the respective polling places hereinafter named on Tuesday, November 6, 2018, between the hours of 7:00 a.m., at which time the polls will open, and 7:00 p.m., at which time the polls will close, to vote by Australian ballot on the following articles:

Article 1: Shall the District vote to amend Article 12 of the Articles of Agreement as set forth below? (Note: deleted language in strikethroughs; new language italics underlined)

*Article 12 – Annual Budget ~~and Australian Ballot Voting~~, Public Questions and Election of School Directors.*

*The Unified District Board of School Directors shall propose annual budgets in accordance with 16 VSA Chapter 11. The annual budget vote, the election of ~~board members~~, at large school directors and other public questions shall be conducted by Australian ballot pursuant to 17 VSA Chapter 55. The ballots shall be comingled.*

*School directors who are elected by the electorate in individual towns shall be elected at an annual or special meeting of the town. Such election shall be by Australian ballot in those towns that elect their town school directors by Australian ballot. In any town not using the Australian ballot system to elect school directors, the electorate may vote, pursuant of the provisions of Title 17 Chapter 55, at any annual or special meeting to use the Australian ballot system to elect its school director(s) to the Unified District.*

*Effective date of Amendment January 1, 2019.*


Article 2: Shall the District vote to establish the fourth Tuesday of March as the date for the District's 2019 Annual Meeting and each year thereafter?

Said persons and voters are warned and notified that voter qualifications, registration, absentee voting, and voter procedures shall be in accordance with Chapters 43 and 51 of Title 17 Vermont Statutes Annotated.
